The opening plenary of the Energy Action Day will set the stage for discussions on how to advance energy transitions worldwide at the speed and scale needed to achieve global climate and development goals. It will highlight key challenges and the role of government and private sector actors, individually as well as through partnerships, in raising ambitions.

Damilola Ogunbiyi, CEO SEforALL, and UN Secretary-General Special Representative

Damilola Ogunbiyi is the CEO of Sustainable Energy for All (SEforALL), Special Representative of the UN Secretary-General for Sustainable Energy for All and Co-Chair of UN-Energy. She is also a Commissioner for the Global Commission to End Energy Poverty and the Co-Chair of the COP26 Energy Transition Council. She is a global leader and advocate for the achievement of Sustainable Development Goal 7 (SDG7). Ms. Ogunbiyi was the first female Managing Director of the Rural Electrification Agency of Nigeria from May 2017 to December 2019. She was also the Senior Special Assistant to the President of Nigeria, Muhammadu Buhari, and Head of the Advisory Power Team within the Office of the Vice-President.

Ms. Ogunbiyi is a commentator on renewable energy access, the Sustainable Development Goals and the inclusion of women and youth in the energy sector. She has written about the importance of energy access for health-care services during the COVID-19 pandemic and how energy access can support economic recovery from the pandemic in countries like Nigeria.

She is a Commissioner for the international think-tank the Energy Transitions Commission, and a Commissioner for the Global Commission to End Energy Poverty, an initiative by the Massachusetts Institute of Technology (MIT) and Rockefeller Foundation.



Francesco La Camera, Director-General, International Renewable Energy Agency (IRENA)

Francesco La Camera is the Director-General of the International Renewable Energy Agency (IRENA). He was appointed at the Ninth Assembly of IRENA, the ultimate decision-making body of the Agency. Mr. La Camera took office on 4 April 2019 and brings more than thirty years of experience in the fields of climate, sustainability, and international cooperation. In his role, Mr. La Camera is responsible for leading the delivery of IRENA's work programme and strategy in cooperation with the Agency's member states.

Previously, Mr. La Camera served as Director-General of Sustainable Development, Environmental Damage, EU and International Affairs at the Italian Ministry of Environment, Land and Sea since 2014. Mr. La Camera held number of roles at the Italian Ministry of Environment, Land and Sea. As the national coordinator for climate, environment, resource efficiency and circular economy, he led the Italian delegation to UNFCCC's COP 21 to 24 and the EU Presidency at COP 20.

Author of many publications, Mr. La Camera was a Lecturer of Sustainable Development at the University of Cosenza and of Environment & Land Economics at the University of Roma 3. He began his career as an economic analyst at the Italian Ministry of Budget and Planning. Mr. La Camera is a graduate of the University of Messina in Political Sciences (Economic Policy major).



Amina Mohammed, Deputy Secretary General of the United Nations

Amina J. Mohammed is the Deputy Secretary-General of the United Nations and Chair of the United Nations Sustainable Development Group. Prior to her appointment, Ms. Mohammed served as Minister of Environment of the Federal Republic of Nigeria where she steered the country's efforts on climate action and efforts to protect the natural environment.

Ms. Mohammed first joined the United Nations in 2012 as Special Adviser to former Secretary-General Ban Ki-moon with the responsibility for post-2015 development planning. She led the process that resulted in global agreement around the 2030 Agenda for Sustainable Development and the creation of the Sustainable Development Goals. She has been conferred several honorary doctorates and has served as an adjunct professor, lecturing on international development. The recipient of various global awards, Ms. Mohammed has served on numerous international advisory boards and panels. She is the mother of six children and has two grandchildren.



H.E. Mette Frederiksen, Prime Minister of Denmark

Mette Frederiksen has served as Prime Minister of Denmark since 2019, and as party leader of the Social Democratic party since 2015.

Prime Minister Frederiksen served as Minister for Justice (2014-2015), Minister for Employment (2011 – 2014) and Deputy party leader of the Social Democratic Party (2005-2011). Frederiksen has been a Member of the Danish Parliament since 2001. Following her election to the parliament, she was named as her party's spokesperson for culture, media, and gender equality. Prime Minister Frederiksen holds a Bachelor of Administration and Social Science from Aalborg University (2007) and Master's degree in African Studies from the University of Copenhagen, 2009.



Sharan Burrow, General Secretary of the International Trade Union Confederation

Sharan Burrow is the General Secretary of the International Trade Union Confederation (ITUC), representing 200 million workers in 163 countries and territories with 332 national affiliates. The ITUC's primary mission is the promotion and defence of workers' rights and interests, through international cooperation between trade unions, global campaigning and advocacy within the major global institutions.

Previously President of the Australian Council of Trade Unions (ACTU) from 2000 – 2010, Ms. Burrow is a passionate advocate and campaigner for social justice, women's rights, the environment, and labour law reforms, and has led union negotiations on major economic reforms and labour rights campaigns in her home country of Australia and globally. Ms. Burrow has also served as a member of the Governing Body of the International Labour Organisation and is represented on a number of international commissions concerning climate action, industrial transition, and economic reform.



Roeland Baan, CEO of Haldor Topsøe

Roeland Baan joined Topsoe as President and CEO in June 2020.

From 2016 to 2020, Mr. Baan was President and CEO of Outokumpu, a global stainless steel company listed on the Finnish stock exchange. Previously, Mr. Baan held a wide range of global CEO and Executive Vice President (EVP) positions at Aleris International, Arcelor Mittal, SHV NV, and Shell.

Mr. Baan is Chairman of the Board of SBM Offshore NV. In addition, he is Vice Chairman of the International Stainless Steel Forum and member of the Executive Committee of Eurofer. Mr. Baan holds a M.Sc. in Economics from Vrije Universiteit Amsterdam.

Anthony Robert Hobley, Co-Executive Director, Mission Possible Partnership and an Executive Fellow, WEF

Anthony Hobley is the Executive Director of the Mission Possible Platform a partnership between the World Economic Forum and the Energy Transitions Commission. He was Chief Executive Officer of the Carbon Tracker Initiative from February 2014 to March 2019, and now is co-chair of the Advisory Board. Previously he was a partner and Global Head of the Sustainability & Climate Finance Practice at global law firm Norton Rose Fulbright. Formerly he was General Counsel to the Climate Change Capital Carbon Fund and Director of Legal Policy for Climate Change Capital which he joined in September 2005.

Mr. Hobley specialised in climate change and clean energy law as well as UK, EU and international environmental law. He has played a key role in helping to design the UK's pilot emissions trading scheme and in developing key aspects of the EU ETS. He advised a wide range of banks, trading companies, project development companies, corporates and public sector entities who were active participants in carbon markets. Mr. Hobley was seconded to Norton Rose Fulbright's Sydney office between 2010 and 2012 where he was heavily involved in the development of the emerging carbon and clean energy markets in Australia and Asia. He was a key figure behind the creation of the business advocacy group Businesses for a Clean Economy, a coalition of business arguing for a price on carbon. He was behind the creation of the business group Climate Markets & Investment Association. He sat on the board of the Verified Carbon Standards Association (now Vera) between 2007 and 2015. He currently sits on the Advisory Board to the Climate Bonds Initiative and the Global Footprint Network. Mr. Hobley has recently been a senior advisor to the UN Principles for Responsible Investment (PRI), the specialist climate events and media company Climate Action and the Global Law Firm Clyde & Co. Anthony holds a First-Class Honours Degree in Chemistry & Physics and an LLM in Environmental Law. He qualified as a solicitor of England and Wales in 1994. He writes and speaks widely on climate risk and the financial sector.



Mahendra Singhi. Managing Director & Chief Executive Officer at Dalmia Cement Ltd.

Mr. Mahendra Singhi is an affable and cheerful person. He is designated as Carbon Pricing Champion by the World Bank Group, COP 26 Business Leader by UN COP 26 Presidency and recognised as Climate Defenders by the BBC World.

Mr. Singhi is Managing Director and CEO of Dalmia Cement, a prominent cement manufacturing group in India ranked no.1 globally by CDP on Low Carbon Economy Transition and appreciated by the UN Secretary-General on climate innovation. Dalmia Cement has already committed, in 2018, to become a carbon-negative cement group by 2040. It follows the business philosophy of Clean and Green is profitable and sustainable while having one of the lowest carbon footprints in global cement sector.



Svein Tore Holsether, President and Chief Executive Officer, Yara International

Svein Tore Holsether (born 1972) is President and Chief Executive Officer of Yara International since 2015.

Mr. Holsether is passionate about promoting the Sustainable Development Goals in the global business arena. To contribute to a thriving future and drive inclusive growth, he is member of the Executive Committee, Chair of the Food & Nature program for the World Business Council for Sustainable Development (WBCSD), member of the steering committee of IMAGINE Food Collective, a nature champion and member of the Alliance of CEO Climate Leaders at the World Economic Forum (WEF). He was a Commissioner of the Business and Sustainable Development Commission (BSDC), and also serves as Chair of the International Fertilizer Association (IFA). In 2021, he was elected President of NHO, the Confederation of Norwegian Enterprise. Previously, Mr. Holsether has held a range of executive and senior position in large industrial companies. Mr. Holsether has a BSc degree, specializing in Finance & Management, from the University of Utah, USA.



Gerhard Salge is the Chief Technology Officer - CTO for Hitachi ABB Power Grids.

He joined Hitachi ABB Power Grids' predecessor in 1999 working within Corporate Research. From 2005 to 2007, he was Global Technology Manager within the Medium Voltage Products Business Unit. From 2007 to 2014, he was responsible for the global R&D within the total Business Unit. In 2015 he became Global Head of Technology for Power Products, then Business Chief Technology Officer – CTO for Power Grids in 2016.

Dr. Salge holds a M.Sc. and a Ph.D. in Electrical Engineering from RWTH Aachen University, Germany.



Tareq Emtairah, Director, Department of Energy, UNIDO

Mr. Tareq Emtairah has joined the UNIDO family as the Director of the Department of Energy. Mr. Emtairah's work experience spans over 22 years in developed and emerging economies with a progressive focus on sustainable industrial transformation, energy transition, policy advocacy, applied research and capacity development. Before joining UNIDO, he worked as a senior research fellow at the International Institute for Industrial Environmental Economics (IIIEE) at Lund University, Sweden where he worked with research and analysis on the transition to low carbon economies with a focus on cleaner technologies and cities. From June 2012 to June 2015, he served as the executive director of the Regional Center for Renewable Energy and Energy Efficiency (RCREEE), an inter-governmental technical cooperation center based in Cairo, where he drove for the conceptualization, development and implementation of the programmatic areas of the Center for advancing policies and strategies for sustainable energy in the MENA region. Mr. Tareq Emtairah is a graduate of Lund University-Sweden, where he received a PhD in Industrial Environmental Economics (2009), and Rutgers University-USA, where he received his BS in Materials Engineering (1990).



Melanie Nakagawa, White House Special Assistant to the President and NSC Senior Director for Climate and Energy

Melanie Nakagawa serves as the Special Assistant to the President and Senior Director for Climate and Energy at the National Security Council. Her work includes the U.S. return to the Paris Agreement and advancing the Biden-Harris Administration’s policy of integrating climate change into U.S. foreign policy and national security. Most recently, she was the Director of Climate Strategy at Princeville Capital, leading their climate-focused strategy to invest in global growth-stage technology-enabled companies delivering transformative solutions to climate change, and launching their inaugural climate tech fund.

Prior to her investment role, she served in the Obama-Biden administration as the Deputy Assistant Secretary for Energy Transformation at the U.S. State Department and was a strategic advisor on climate change to the U.S. Secretary of State John Kerry. Earlier in her career, she was the Senior Energy and Environment Counsel for the Senate Foreign Relations Committee and an attorney with the Natural Resources Defense Council.

Nakagawa earned a J.D. from American University Washington College of Law, an M.A. in International Affairs from American University’s School of International Service, and an A.B. from Brown University.

Kate Abnett, European Climate and Energy Correspondent at Reuters

Kate Abnett is a journalist covering climate change and energy for Reuters, based in Brussels. Previously, Ms. Abnett was a senior reporter at Argus Media, where she covered European emissions and climate policy. Her focus was carbon markets, and she also covered UN climate negotiations, European energy markets, and environmental issues in the transport, aviation and shipping sectors.



H.E. Dan Jørgensen, Minister for Climate, Energy and Utilities, Denmark

H.E. Mr. Dan Jørgensen was appointed Minister for Climate, Energy and Utilities in 2019. Prior to his appointment, he served as Minister for Food, Agriculture and Fisheries from 2013 to 2015 and Vice-chairman of the parliamentary group of the Social Democratic Party. H.E. Mr. Jørgensen was a Member of the European Parliament from 2004 to 2013, and President of the Animal Welfare Intergroup. He has also served as Vice-chairman of the European Parliament Committee on Environment, Public Health and Food Safety and Head of the Danish delegation of Social Democrats in the European Parliament.

H.E. Mr. Jørgensen holds a Masters degree in Political Science from the Aarhus University, 2004. He is the author of numerous publications in the field of climate change and politics.



H.E. Andrea Meza Murillo, Minister of Environment and Energy, Costa Rica

H.E. Ms. Andrea Meza Murillo was appointed Minister of Environment and Energy of Costa Rica in August 2020. Prior to her appointment, she was the Director of Climate Change for Costa Rica since 2015, where she directed the formulation and implementation of the National Adaptation Strategy and the National Decarbonisation Plan with a view to eliminate Costa Rica's reliance on fossil fuels by 2050. She has over 20 years of experience in formulating public policies and executing projects related to sustainable development.

H.E. Ms. Meza Murillo has worked in more than 15 Latin American countries in multidisciplinary projects financed by various multilateral organisations and national governments. She has participated in the negotiation by Costa Rica of the Paris Agreement and has been key in strengthening programs that coordinate efficiency and sustainability actions with private companies and the municipal sector. H.E. Ms. Meza graduated from the University of Costa Rica with further specialisation courses at the University of Utrecht and holds a PhD in Local Development.



Christiana Figueres, Founding partner, Global Optimism and former Executive Secretary, UNFCCC

Christiana Figueres is a Costa Rican citizen and was the Executive Secretary of the United Nations Framework Convention on Climate Change 2010 - 2016.

During her tenure, Ms. Figueres brought together national and sub-national governments, corporations and activists, women's groups, scientists and spiritual communities, financial institutions and NGOs to jointly deliver the historic 2015 Paris Agreement on Climate Change. Under this Agreement, 195 sovereign governments decided on a collaborative path to limit future global warming to well below 2°C, and strive for 1.5°C in order to protect the most vulnerable in every nation. For this achievement Ms. Figueres has been credited with forging a new brand of collaborative diplomacy, for which she has received multiple awards.

Since then Ms. Figueres has continued to foster rapid action on climate change, She is the co-author of *The Future We Choose*, *The Stubborn Optimist's Guide to the Climate Crisis* (Penguin Random House 2019) and co-host of the podcast *Outrage and Optimism*. She also sits on the Board of ACCIONA and ACCIONA Energía.

She is a graduate of Swarthmore College and the London School of Economics and has been awarded multiple honorary doctorate degrees from academic institutions such as Yale, University of Massachusetts, Georgetown and University of Edinburgh. After decades of living and working abroad, she has moved back to her beloved Costa Rica. She has two fantastic daughters, Naima and Yihana, fountains of much joy.

Andy Deacon, Acting Managing Director, Global Covenant of Mayors

Andy Deacon has been part of the Global Covenant of Mayors secretariat team since January of 2020 and is working to guide programme management and delivery across all of GCoM's areas of activity. GCoM is the largest global alliance for city climate leadership and is built on the commitment of over 10,000 cities and local governments. These cities hail from 6 continents and 140 countries. By 2030, Global Covenant cities and local governments could account for 2.3 billion tons CO₂e of annual emissions reduction.

Mr. Deacon has worked for 25 years across a range of environmental protection issues focusing on climate change, energy and air quality in local, regional and central government, academia and NGOs. He has advised Mayors and Ministers on city scale carbon reduction and climate adaptation, community energy, home retrofit and air quality. Mr. Deacon has a BSc in Geography and Environmental Studies from the University of Surrey Roehampton Institute and an MSc in Applied Meteorology and Climatology from the University of Birmingham.



Shri Durga Shanker Mishra, Secretary, Ministry of Housing and Urban Affairs, India

Currently working as Secretary to Government of India in the Ministry of Housing and Urban Affairs since June 2017, Mr Durga Shanker Mishra belongs to 1984 batch of Indian Administrative Service (IAS) from Uttar Pradesh cadre. He has held various senior assignments in Union and State Governments covering Revenue Administration, Internal Security, Vigilance, Civil Aviation, Tourism, Sports, Agriculture & Research, Taxation, Medical & Health, Mining and

Urban Development. He has served as Principal Secretary to the Chief Minister of Uttar Pradesh for over two years

BTech in Electrical Engineering from IIT Kanpur, Mr Mishra is MBA in International Business from University of Western Sydney, Australia and Post Graduate Diploma in Public Policy from the Institute of Social Studies, The Hague, Netherlands. He has taken keen interest in promoting good governance and has published various papers on the subjects related to good governance, public administration and development administration in national/ international journals and books. He has represented Union/ State Government at various national/ international fora and participated in such Workshops/ Conferences. He had been visiting faculty in the University of Guelph, Canada. Mr. Mishra is fond of trekking, sports and tourism.



Anna König Jerlmyr, Mayor of Stockholm, Sweden

Anna König Jerlmyr was elected as Mayor of Stockholm in 2018. The green-blue political coalition led by Mayor König Jerlmyr focuses on innovation and sustainability when futureproofing the city and creating opportunities for growth and quality of life for its citizens.

Mayor König Jerlmyr is currently Co-Chair of C40's Steering Committee and lead on business collaboration, a member of Friends of Europe's Board of Trustees and a member of World Economic Forum's Supervisory Board of the net zero cities initiative. During König Jerlmyr's leadership, Stockholm has been awarded for its Smart City Strategy and Stockholm was subsequently selected as the "smartest city in the world" by the Smart City World Expo Congress in 2019.

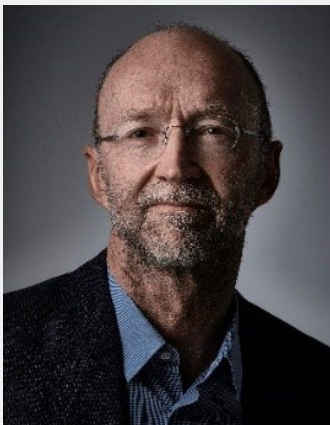
Anna König Jerlmyr was born in Uppsala, Sweden, in 1978 and has a background in economics and communications. König Jerlmyr was a member of the Swedish Parliament 2006 -2010 and was previously Vice Mayor for Social Affairs and Chair of Stockholm's Police Authority. In 2014 - 2018 König Jerlmyr acted as the Opposition vice Mayor, representing the Moderate Party.



Cécile Prévieu, Executive Vice President, Energy Solutions, ENGIE

Cécile Prévieu is a graduate of the Ecole Polytechnique, the Ecole Nationale des Ponts et Chaussées and the Institut d'Etudes Politiques de Paris. She began her career in the French government, notably at the Ministry of the Economy, Finance and Industry, as energy advisor to the Minister of Industry, then as transport advisor to the Prime Minister.

Ms. Prévieu joined ENGIE in 2010, where she held positions of responsibility in the Group's Infrastructure Division, before being appointed Director of Asset Management at Storengy. Since 2015, she was Managing Director of Storengy. She secured the storage activity in France through regulation and developed Storengy on decarbonated activities: production and storage of renewable gas (biomethane, hydrogen and e-methane) and supply of heat and cold through geothermal energy for cities and eco-districts.



Matthew Baldwin, Deputy Director-General, DG MOVE, European Commission

Matthew Baldwin is a European Commission official: he is Deputy Director-General of DG MOVE where he has been since July 2016. Amongst his principal professional activities, Mr. Baldwin is Manager of the Commission's Mission for 100 Climate Neutral Cities by 2030; he is the EU Coordinator for road safety and sustainable urban mobility; and he is also managing the Commission's crisis network of COVID-19 transport contact points.

In his Commission career of more than 20 years, Mr. Baldwin has served in the cabinets of President Barroso, Commissioner Lamy, and Commissioner Hill, the last as Head of Cabinet. He has also been Director of Market Access and Industry in DG Trade and Director of Aviation in DG MOVE.

Mr. Baldwin is of Italian and British nationality, has two sons, speaks English, French and Italian and lives in Brussels.



Irací Hassler Jacob, Mayor, Santiago, Chile

Irací Hassler Jacob was elected Mayor of Santiago in 2021. After years of being a member of the Communist Youth (JJ.CC), Mayor Hassler was elected as municipal councillor in Santiago for a term ending in 2020 and extended to 2021 due to the COVID-19 pandemic.

In the May 2021 election, Mayor Hassler ran as a mayoral candidate against the incumbent Mayor Felipe Alessandri (RN), winning a victory for the Communist Party of Chile as the first communist Mayor of Santiago. Her term will run from 2021-2024 and in that time ending food insecurity and discrimination against migrants in Santiago are top priorities of her incoming administration.

Having studied commercial engineering at the University of Chile, Mayor Hassler set out to champion free public education being involved in the leadership of the University of Chile Student Federation and was a member of the Communist Youth of Chile (La Jota) during her student career. Once graduated, Mayor Hassler pursued a career as an economist before entering politics. Elected as a Santiago municipal councillor in 2016, she was elected as a candidate in Citizen Primary in December 2020.

Mayor Hassler has been described as, “the new face of feminism and environmentalism” in Chile. As an advocate for municipal socialism, Mayor Hassler strives for positive transformation of people’s lives, for a clean and sustainable Santiago, public education, the right to work, public parks, and the protection of women’s rights.

Glenn Pearce-Oroz, SEforALL

Glenn Pearce-Oroz is the current Senior Director for International Relations and Special Projects at Sustainable Energy for All. He joined SEforALL in 2018 after 15 years with the World Bank. As part of SEforALL's leadership team, Mr. Pearce-Oroz manages the strategic engagements of SEforALL with key global partners to prioritize greater progress on Sustainable Development Goal 7 and the global energy transition.

He has led SEforALL's engagement with the G20 Energy Transition Working Group as well as SEforALL's support of the COP26 Energy Transition Council process to raise energy transition ambition among selected countries. For the past 18 years prior to joining SEforALL, Mr. Pearce-Oroz was working from country offices in Latin America, South Asia, and Africa. He is now based in Vienna, Austria.



Alok Sharma President for COP 26, the 26th United Nations Climate Change Conference

Rt Hon Alok Sharma was appointed full-time President for COP 26, the 26th United Nations Climate Change Conference, on 8 January 2021. He was previously Secretary of State for Business, Energy and Industrial Strategy and President for COP 26 between 13 February 2020 and 8 January 2021. He was previously Secretary of State for International Development from 24 July 2019 to 13 February 2020, and Minister of State for Employment at the Department of Work and Pensions from 9 January 2018 until 24 July 2019. He was Minister of State for Housing and Planning, for the Department for Communities and Local Government from 13 June 2017 to 9 January 2018.

Hon. Sharma was Parliamentary Under Secretary of State at the Foreign and Commonwealth Office from 17 July 2016 to 13 June 2017. He has served as a member of the Commons Treasury select committee, a member of the Commons Science and Technology select committee, a Parliamentary Private Secretary at the Treasury and from 2012 to 2015 as a Conservative Party Vice Chairman. He

was appointed in 2016 as the Prime Minister's Infrastructure Envoy to India. On July 29th, 2011, he assumed the position of Undersecretary of Housing, where he continued the work of reconstruction. In 2002, he joined Enel as Director of Group Corporate Strategy and a member of the management committee, contributing significantly to the development of the company's gas strategy. In 2004 he became Chief Financial Officer of Wind Telecom and oversaw the sale of Wind to Orascom. In 2005 he moved to Eni where he worked for more than 10 years holding various positions of increasing responsibility. He joined the company as Director of Supply & Portfolio Development at the Gas & Power Division, successfully navigating the group through the Russia-Ukraine gas crisis in the Winter of 2006. Previously, he served as the Vice-chairman for the Committee on European Affairs in 2020, Chair of the parliamentary group of the Social Democratic Party 2019-2020, Vice-chairman of the Committee on Health and Senior Citizens 2015-2016, Vice-chairman of the Committee on Health- and Prevention, 2012-2013, and Chair of the Cultural Affairs Committee, 2011-2015.

Ms. Ligia Noronha began her role as United Nations Assistant Secretary- General and Head of the New York Office at UNEP on 1 April 2021. In this role she works in establishing and maintaining critical links with the Permanent Missions of Member States to the United Nations, the United Nations Secretariat, other UN System organizations and entities headquartered in New York, major groups, civil society organizations, academia and the private sector. Through her leadership of the New York Office, she seeks to promote effective integration of the environmental dimension in the UN System, in the inter-agency mechanisms and in the intergovernmental processes while raising awareness of emerging environmental issues and the outcomes of the United Nations Environment Assembly.

An economist with over 30 years of international experience in the field of sustainable development, Ms. Noronha previously served as Director of UNEP's Economy Division based in Paris and Nairobi, leading UNEP's work on climate mitigation and energy transitions; on inclusive green economies, circularity and sustainable consumption and production, as well as on trade and sustainable finance; on extractives, and the nexus of environment, pollution and health. During her tenure, Ms. Noronha positioned the Economy Division as a center for integrated actions in support of the 2030 Agenda.

Prior to joining UNEP, Ms. Noronha worked as Executive Director at The Energy and Resources Institute (TERI) in New Delhi; she served as Secretary of the Asian Energy Institute and as Coordinator of the Renewable Energy and Energy Efficiency Partnerships (REEEP), and worked with the International Development Research Centre (IDRC), Canada.

She holds a Master's degree in Economics from the University of Mumbai, as well as a Master's degree in Sea Use Law, Economics and Policy and a Ph.D. from the London School of Economics. Ms. Noronha is married with three children.



Mike Bloomberg, United Nations Secretary-General's Special Envoy for Climate Ambition and Solutions, and as WHO Ambassador for Noncommunicable Diseases and Injuries

Mike Bloomberg is an entrepreneur and three-term mayor of New York City whose innovations in business, government, and philanthropy have made him a pioneering leader on critical issues facing America and the world. He has launched major efforts to save and improve lives, including America's largest campaigns to prevent gun violence and fight the climate crisis, and global initiatives to tackle pressing public health issues.

Elected mayor just weeks after the attacks of September 11, 2001, Bloomberg led New York City's resurgence. Bloomberg reduced carbon emissions by 13 percent, increased New Yorkers' life expectancy by three years, and – despite the Great Recession – led the city to record job growth. After his third term in City Hall, he resumed leadership of Bloomberg LP, the financial technology and media company he founded in 1981 and expanded his philanthropic work. Bloomberg LP now employs some 20,000 people globally, and Bloomberg Philanthropies invests in 810 cities and 170 countries around the world, focusing on five key areas for creating lasting change: Environment, the Arts, Education, Government Innovation, and Public Health. He has also launched a series of programs to fight the COVID-19. Bloomberg has given away more than \$11 billion.

A longtime champion in the fight against climate change, he leads a number of national and international efforts to make progress. Bloomberg serves as President of the Board of the C40 Cities Climate Leadership Group, and he co-chairs both the Global Covenant of Mayors for Climate & Energy and the “America Is All In” coalition. His partnership with environmental groups has helped retire more than 60% of all U.S. coal plants since 2011 and more than half of all European plants since 2016. He also works to involve the financial community in the climate fight as chair of the Task Force on Climate-related Financial Disclosures, which provides companies with recommendations to guide their disclosure of climate-related risks and opportunities, and the Climate Finance Leadership Initiative, which aims to accelerate private sector investment in climate solutions.

Bloomberg graduated from Johns Hopkins University and Harvard Business School. He is the father of two daughters, Emma and Georgina, and has two grandchildren.



Fatih Birol, Executive Director, International Energy Agency

Dr Fatih Birol has served as Executive Director of the International Energy Agency since 2015. Under his leadership, the IEA has moved to the forefront of global efforts to reach international climate goals while ensuring that the social and economic impacts of clean energy transitions are at the heart of policy-making and energy security is safeguarded.

Dr Birol took up his current position after rising through the ranks of the IEA over two decades. He joined as a junior analyst in the mid-1990s and rose to the position of Chief Economist responsible for the IEA's flagship World Energy Outlook. Dr Birol has been named by Forbes as one of the most influential people in the world of energy and by the Financial Times as the Energy Personality of the Year. He chairs the World Economic Forum's (Davos) Energy Advisory Board. He is the recipient of numerous state decorations, including the Japanese Emperor's Order of the Rising Sun, the Order of the Polar Star from the King of Sweden and the highest Presidential decorations from Austria, Germany and Italy.

Before the IEA, Dr Birol worked at the Organisation of the Petroleum Exporting Countries (OPEC) in Vienna for six years. He earned a BSc degree in power engineering from the Technical University of Istanbul and received an MSc and PhD in energy economics from the Technical University of Vienna. Dr Birol was awarded a Doctorate of Science honoris causa from Imperial College London in 2013. He is an honorary life member of Galatasaray Football Club.



H.E. Dan Jørgensen, Minister for Climate, Energy and Utilities, Denmark

H.E. Mr. Dan Jørgensen was appointed Minister for Climate, Energy and Utilities in 2019. Prior to his appointment, he served as Minister for Food, Agriculture and Fisheries from 2013 to 2015 and Vice-chairman of the parliamentary group of the Social Democratic Party. H.E. Mr. Jørgensen was a Member of the European Parliament from 2004 to 2013, and President of the Animal Welfare Intergroup. He has also served as Vice-chairman of the European Parliament Committee on Environment, Public Health and Food Safety and Head of the Danish delegation of Social Democrats in the European Parliament.

H.E. Mr. Jørgensen holds a Masters degree in Political Science from the Aarhus University, 2004. He is the author of numerous publications in the field of climate change and politics.



Gonzalo Muñoz, High Level Climate Champion for the 25th Conference of the Parties (COP25)

Appointed by the Chilean presidency and the United Nations as High-Level Climate Champion for the 25th Conference of the Parties (COP25) of the United Nations Convention on Climate Change, to mobilize climate action in non-state actors around the world. Previously, he co-founded and led TriCiclos, one of the most recognized Latin American companies in circular economy and recycling. Inspired by 10 years of running traditional food businesses where he witnessed the waste generated by the private sector, he set out to offer a transformative service that would help the environment while being financially sustainable. Using his entrepreneurial and business knowledge, he redirected his efforts towards the ideals and passion for sustainability and the environment. Today, TriCiclos operates in 13 countries in Latin America, where its mission is to foster new designs and business models for a world without waste. TriCiclos was also the first company to be certified as a B company outside North America. Gonzalo co-founded Sistema B and is a board member of BLab global. He is currently an advisor to the National Water, Green Hydrogen, Electromobility and Circular Economy Committees.
